Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Jefferson City had a lack of rental housing for the Low and Very Low income before the Tornado in 2019. Now working individuals really struggle to find affordable housing, once they pay 30% of their income to rent, they struggle to pay the expenses for the vehicle they need to get to work, especially in a two-income family. The HVC program has struggled for at least 20 years to lease up the 231 Housing Choice Vouchers and now we have 4 additional to lease. We issue the voucher, the voucher expires/is Ported to another jurisdiction, that jurisdiction absorbs and returns our voucher to us, then we reissue and start the process over. Everywhere you look, local businesses have help-wanted signs posted. Two of the larger manufacturers shuttle in their employees from Fulton and Kingdom City where they could find housing for their employees one employer bought an old hotel to house his employees. The Housing Authority applied and received a waiver to increase the Payment Standards to 120% of the FMRs, allowing JCHA to pay a higher rent for our participants.</p> <p>The working class in Jefferson City struggles to find affordable housing, we inform individuals when we issue a voucher, should they not be able to find anything, they can move to public housing and try again later. About a fourth of the waiting list for Housing Choice Vouchers includes individuals in the public housing program, hoping to move up and out of poverty.</p> <p>The Housing Authority is no longer using the Minimum Rent requirement (Minimum Rent of \$50) and is basing rent on 30% of adjusted or 10% of gross monthly income for the Public housing and Housing Choice Voucher units.</p> <p>The Housing Authority Pet Policy has redefined “pets temporarily on-premises” to include no wild/feral animals, to help lower the number of unvaccinated animals on property threatening the health and safety of residents and their pets.</p> <p>(c) The PHA must submit its Deconcentration Policy for Field Office review.</p> <p>No changes have been made to the Deconcentration Policy, submitted for HUD review.</p> <p>The PHA will review resident income on an annual basis and use a local preference to help in maintaining deconcentration goals.</p>

The Housing Authority continues to search for and find grants to fund security, safety, and capital improvements.</p> <p>The Authority was awarded the Safety and Security Grant for Amp 9-3 Dulle Tower cameras and door systems.</p> <p>The Housing Authority through the Housing Choice Voucher Program has a thriving FFS program, with 30 proud graduates and a Homeownership program, with three successful homeowners.</p>




