	Choice Neighborhoods: The City of Jefferson has asked the PHA to partner with them in an application for Choice Neighborhoods. We are in the very beginning stages of preplanning & preparing requests for studies.
	Disposition: The Housing Authority is in negotiations to sell the Cherry Street Day Care non-dwelling building, to the CMCA Head Start Program, plans to move forward and submit for HUD approval have stalled a bit, but soon to come.

Approved Vacancies: The Authority has ongoing approved vacancies for modernization, rehabilitation, and casualty loss.

The Housing Authority continues to search for and apply for grants to fund security, safety, and capital improvements: such as plumbing, tub & shower surround replacements, flooring, HVAC, windows, doors, termite damage, electrical, interior & exterior lighting, and security system upgrades to name a few. We plan to apply for lighting grants to help with extremely dark areas on properties and to upgrade existing lighting to LED, and air conditioning grants to keep humidity levels in units normal, and any other grants that will make our units safer, more energy efficient, and a great place to call home.

The Housing Authority through the Housing Choice Voucher Program has a thriving FFS program, with 36 proud graduates and a Homeownership program, with three successful homeowners. A waiver was received to increase payment standards to 120%, this will end on 12/31/2023 unless HUD decides to extend. We are in the process of requesting SAFMRs to help offset this decrease in the payment standards. As our housing market is so tight we have to be able to compete with individuals who can pay above-market rents to get available apartments. We have requested the process to return the additional 4 units of subsidy awarded last year back to HUD, and hope to accomplish that this year. Received funding 3 FYI vouchers in May of 2023, that leased elsewhere before we received approval. HUD has been notified of the non-leased status and should recapture these vouchers.

B.3 Progress Report.

Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year and Annual Plan.

The need for housing in Jefferson City is crucial to growing our city into a vibrant thriving community. Jefferson City had a lack of rental housing for Low and Very Low-income families before the Tornado in 2019. Now working individuals really struggle to find affordable housing, once they pay rent, they struggle to pay the expenses for the vehicle they need to get to work. The HVC program has struggled for at least 20 years to lease up the 231 Housing Choice Vouchers and 4 additional were added last year. We have requested the process to return those additional 4 units of subsidy back to HUD, and hope to accomplish that this year. Our process when we issue the voucher is the voucher either expires or is Ported to another jurisdiction, that jurisdiction absorbs the voucher and returns the voucher back to us, and we reissue and start the process over. Everywhere you look, local businesses have help-wanted signs posted. Two of the larger manufacturers shuttle in their employees from Fulton and Kingdom City where they could find housing for their employees, one employer bought an old hotel to house the employees. We have supported local developers in their requests for ARPA funds and LIHTCs, in hopes they will be approved and build more housing, but this will not be an instant fix as most projects, if awarded will take 2-3 years before they lease.

The Authority was awarded the Safety and Security Grant for Amp 9-3 Dulle Tower cameras and door systems, which is underway; awarded an Emergency Grant for Decks and Balconies which is underway; Hazards Grant for Asbestos flooring removal that is in preparation for bidding; Safety and Security Grant for Fire & Pull Cord system replacement, that is in preparation for bidding. We have applied for an AHP Grant for numerous upgrades at Amp 090-000005, including replacement of the HVAC system, plumbing upgrades/repairs, flooring replacement, alteration of some units' access to appliances and cleanouts, replacement of smoke detectors, concrete work, siding and facial repairs, painting, security system upgrades, and other misc. work to keep units safe.

We have continued to do renovations to offline units due to asbestos flooring, termite-damaged areas, water-damaged poorly designed underlayment of flooring, plumbing replacements of thin-walled deteriorating copper drain & sewer lines, decks, balconies, floods & fires.
